to prioritise guests’ well-being, including a new cleaning regime and safe distancing protocols. We look forward to welcoming guests back to our award-winning properties, whether it be from domestic travel with more people opting for staycations or international guests as borders start to reopen between certain countries,” said Mr Koh.

Following the easing of local COVID-19 measures in the UK and Europe, Frasers Hospitality has gradually reopened its properties across Germany, France, Switzerland, Spain, England and Scotland.
